THEME: What my healthy community means to me


Why not take out your camera and capture the fabulous scenery all around us and get be in with a chance to win some cash!




Succession Planning: A Guide for Community Archives & Heritage Groups



Mayo County Council Awards €2 Million In Grants Payments To Successful Applicants Of The Croi Conaithe Vacant Property Refurbishment Grant

Mayo County Council is delighted to announce that it has paid out €2 million in grant payments to successful households of the Croi Conaithe Vacant Property Refurbishment grant. This significant milestone comes at the second-year anniversary of the grant, which was established to provide a pathway to home ownership for applicants.

The €2 million in grant payments have been paid across 41 individual households. This figure represents 41 homes that would have been vacant and in some cases derelict which now because of the grant are completely refurbished and back in residential use.

Tom Gilligan, Director of Services in Mayo County Council said: "*The grants and schemes that our Vacant Homes Office administer have real potential to change the landscape of our towns and rural communities. The grants support property owners to bring back much needed vacant and derelict properties into residential use*."

Our Rural Future: Minister Humphreys announces €3 million to enhance visitor experience at Forest Parks across Ireland The Minister for Rural and Community Development, Heather Humphreys, has announced funding of €3 million to develop and upgrade visitor and recreational amenities at Coillte Forest Parks across Ireland.

The investment is part of a strategic partnership between the Department of Rural and Community Development and Coillte to maintain and manage existing trails in Coillte forests, and to develop new recreation opportunities.

Trading for Impact: National Social Enterprise Policy 2024-2027

Trading for Impact: National Social Enterprise Policy 2024 -2027 was launched by Minister for Rural and Community Development Heather Humphreys TD on July 24 2024.

The purpose of the policy is to help cultivate and sustain strong and impactful social enterprises in Ireland to enrich the social, environmental, and economic well-being of people living in our communities. The policy represents a strong commitment by Government to social enterprises and a recognition of their value and potential.

The policy outlines five key objectives:

- 1. Building Awareness of Social Enterprise
- 2. Growing and Sustaining Social Enterprise
- 3. Supporting the Green Transition
- 4. National and International Engagement
- 5. Impact Measurement

57 concrete actions are defined under these objectives, which will be implemented between 2024 to 2027. A Stakeholder Engagement Group will be established to provide oversight for the policy, and annual reports will be published on its implementation.

S3 Solutions consultancy have been commissioned by the Department of Rural and Community Development (DRCD) to carry out a piece of research to explore any barriers to involvement in Public Participation Networks (PPN).

They are keen to explore the demographic characteristics of groups and individuals involved in all 31 PPNs in Ireland and in doing so, investigate the diversity of participation.

Where appropriate, they want to explore the barriers and challenges for diverse groups in actively participating in PPNs.

Minister Humphreys announces €2.6m to support Town Centre First Projects

The Minister for Rural and Community Development, Heather Humphreys TD, has announced funding of €2.6 million to support the development of a wide range of Town Centre First projects. This funding will assist local authorities in creating a pipeline of significant, well-developed projects in local towns across Ireland. A total of 53 projects will be supported with up to €50,000 of funding per project.

This funding will support pre-development works for projects and support costs including detailed design, planning, procurement, professional fees, assessments and other development costs. The Public Participation Network project was established under The Local Government Act 2014 and from 2016 to now has grown from 11,962 groups to 19,950 in 2023, echoing our local growth. This is a monumental representation of community activity in our state and has been led by PPNs in providing empowerment and voice at a local level.

We at **Mayo PPN** thank all those groups, agencies and individuals who have supported us across the ten years and, looking forward, we encourage you and others to join us in continuing the journey to greater inclusion, empowerment and representation of community interests through your PPN.
